

I outline four main reasons justifying my application for this program. First, my professional history and research experience have allowed me to develop strong skills to work in a multicultural environment, to bridge knowledge-production and knowledge-use in policymaking, and finally to value pluralism in terms of ideas and world visions. These tenets are key to foster original thinking and innovation.

Second, since my coming back to Brazil in 2002 after having worked at UNESCO's headquarters in France for eight years, I have engaged with many colleagues and networks from Latin America, South Africa, France, Spain, the USA and Turkey in extensive field research and theory development rooted in comparative methods. These activities have been part and parcel of an intellectual attempt to construct a comparative framework to analyze foreign policy institutions, norms and development cooperation practices in regional powers from the Global South. This fieldwork associated with comparative foreign policy analysis may be an asset to scrutinize the international scenario from a Global South perspective and, in addition, to understand challenges associated with global power shift, new transnational threats (such as climate emergency and pandemics), and *actorness* of regional powers in the developing world. I have published results of this research programme in multiple publications in top-tier journals

Third, particularly since the foundation of the Interdisciplinary Observatory on Climate Change in October 2020, I have been doing systematic research on two main topics:

- (i) The role of veto players in climate change negotiations and how climate obstruction actors justify their narratives and deploy their strategies in Brazil. This research is part of my membership in Brown University's Climate Social Science Network (CSSN);
- (ii) How the climate emergency and the Anthropocene relate to theoretical and conceptual development in International Relations from a Global South perspective. The MIAS grant and research stay will facilitate the conclusion of a book project on the second topic.

A final aspect that I would like to mention is that I have been conducting the research programmes that I coordinate based on fundraising with national and international public and private agencies, and supervising PhD and Master students. In fact, I coordinate two research groups (OIMC and LABMUNDO) and have already supervised 22 PhD students and 38 Master students. I currently supervise 7 PhD and 2 Master students. I am also a Senior Fellow with the Brazilian Center for International Relations (CEBRI), a leading Think Tank in Latin America.
